- 2. To Issue and Allot 20,00,000 Convertible Warrants ("Warrants"), each Warrant convertible into one (1) Equity Share to Promoters of the Company, on a preferential basis in accordance with Chapter V of the SEBI ICDR Regulations and other applicable laws, at a price of Rs. 307/- per Warrant, subject to it being in compliance with the minimum price calculated in accordance with Regulation 164 of Chapter V for Preferential Issue under SEBI ICDR Regulations, subject to the approval of regulatory/ statutory authorities and the shareholders of the Company.
 - Above mentioned Para 1 and 2 are collectively referred to as the "**Preferential Issue**" of the Company.
- 3. Approval for Related Party Transaction up to an aggregate limit of **Rs.500 crores** only subject to approval of shareholders at the ensuing Extra Ordinary General Meeting of the Company to be held on **Thursday**, **October 06**, **2022**.
