I, CS K SRIDHAR, Practicing Company Secretary, was appointed as Scrutinizer by the Board of Directors of M/s. VERANDA LEARNING SOLUTIONS LIMITED (L74999TN2018PLC125880) ("the Company") for the purpose of scrutinizing the voting by Postal Ballot and through e-voting as mentioned in the Postal Ballot Notice issued by the Company and also placed on the Company's website pursuant to Section 110 read with section 108 of the Companies Act, 2013 (the Act) read with and Rule 20(4) and Rule 22(5) of the Companies (Management and Administration) Rules, 2014 as amended ('Rules') and the Regulation 44 of the SEBI (Listing obligations and Disclosure Requirements) Regulations 2015, in respect of resolutions contained in the Postal Ballot Notice dated 23rd January 2023.

The management of the Company is responsible to ensure the compliance with the requirements of the Act and Rules relating to voting by Postal Ballot and evoting for the resolution contained in the Notice. Report on scrutiny:

- 1. The Company has entered into an arrangement with Kfin Technologies Limited ("KFIN") an Agency authorized under the Rules and engaged by the Company to provide e-voting facilities for voting through electronic means to all the members who were eligible to take part in the remote e-voting.
- 2. The cut-off date for the purposes of identifying the shareholders who will be entitled to vote on the resolution placed for approval of the shareholders was on 13th January, 2023 as per Postal Ballot notice issued by the company.
- As prescribed in the Rules, the postal ballot and e-voting facility was kept open for thirty days from Wednesday, 25th January, 2023 (9:00 AM IST) till Thursday 23rd February, 2023 (05.00 PM IST).

- 5. KFIN, the agency was responsible for providing the e-voting platform and maintaining the portal and providing access to members including facilitating members to cast their votes.
- 6. On Thursday, 23rd February, 2023 at 5.30 PM, the votes cast through e-voting were unblocked by me on the Kfin e-voting portal.
- 7. As on, end of working hours of 23rd February, 2023, I have not received any Physical postal ballots from the shareholders of the Company.
