# Sub: <u>Outcome of the Meeting of Board of Directors of Veranda Learning Solutions</u> Limited ("the Company") held on September 25, 2025

This is to inform you that the Board of Directors of the Company at its meeting held today, i.e. Thursday, September 25, 2025, has *inter alia* approved the following.

 Strategic Divestment of Vocational Segment and Consequent Acquisition of 50% Stake in SNVA Edutech Limited

As part of its strategic realignment in the vocational education space, the Company has approved the divestment of its entire Vocational segment — comprising Brain4ce Education Solutions Private Limited and Veranda Management Learning Solutions Private Limited (wholly owned subsidiaries), and Six Phrase Edutech Private Limited (held through its wholly owned subsidiary, Veranda Administrative Learning Solutions Private Limited) — to SNVA Edutech Limited (SNVA), for a consideration other than cash, subject to shareholders' approval at the forthcoming Annual General Meeting.

In consideration for the transfer of these entities, SNVA will allot equity shares to Veranda Learning Solutions Limited and Veranda Administrative Learning Solutions Private Limited, resulting in the Company and its subsidiary collectively holding a 50% equity stake in SNVA Edutech Limited.


Through this, Veranda is working towards allowing its divested businesses along with SNVA to independently unlock value as a large, profitable and market leading entities. Further, this strategic move enables the Company to participate meaningfully in the future growth and direction of SNVA, while unlocking value from its existing vocational education assets.

This partnership creates a uniquely global education platform combining Veranda's strong Indian market and domestic capabilities with SNVA's international footprint. The combined entity will integrate skilling, vocational and higher education operations across India, the USA, UK, France, Italy, Malta, Switzerland and Singapore, positioning itself differently from any competitor.




