# INDEPENDENT AUDITORS' REPORT ON STANDALONE FINANCIAL STATEMENTS TO THE MEMBERS OF BRAIN4CE EDUCATION SOLUTIONS PRIVATE LIMITED

#### Report on the Standalone Financial Statements:

We have audited the accompanying standalone financial statements of **BRAIN4CE EDUCATION SOLUTIONS PRIVATE LIMITED** ("the Company") which comprise the balance sheet as at 31 March 2020, the profit and loss statement and the Cash Flow statement for the year then ended and notes to the standalone financial statements, including a summary of significant accounting policies and other explanatory information.

#### II. Opinion:

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31 March 2020 and its loss and its cash flows for the year ended on that date.

#### III. Basis for Opinion
